SUBJECT: ESRI LICENSE UPGRADE

RECOMMENDATION

The Board of Directors:

1. Approves an upgrade to the ESRI StreetMap Premium license from a single user to a multi-user agreement.

BACKGROUND/ANALYSIS:

Currently, the version of ESRI StreepMap Premium the Center has is only designed for a single user and the license agreement doesn't allow publishing to our Enterprise Portal. As a result, the Center will need to add the uncapped version of StreetMap Premium to our Enterprise Agreement. This will give full access to leverage the data within your CAD/RMS and do all the other work that is being completed prior to the additional workflows we are adding which include:

- A tiled cache map service of StreetMap Basemap combined with a few operational layers (mile markers, call boxes, bike trails, water entry locations, etc)
- An exported mobile map package (mmpk) of the same map service for use offline in the field

This upgrade is necessary to continue to progress on Command Point CAD project build/implementation while adhering to the current timeline.

FINANCIAL ANALYSIS

The current version of ESRI StreetMap Premium single user agreement described above is provided to us at a cost of \$2000 annually. In the Center's board approved FY 2021-22 budget we anticipated a cost increase based on the new CAD build/implementation and budgeted \$5000. The quote we have received from ESRI to upgrade to the mutli-user version is \$6100 annually.

SUBJECT: AXIM GIS SUPPORT BLOCK

RECOMMENDATION

The Board of Directors:

1. Approves a renewal of the GIS support block through AXIM formerly known as GIS, Inc. for 400 hours of GIS support.

BACKGROUND/ANALYSIS:

GIS Support Blocks provide a vehicle for accessing GIS support on demand. In the absence of permanent GIS staff employed by the Center the need for regular GIS input and assistance is necessary as part of a GIS Service Block. In the recent past, SRFECC (the Center) has enjoyed a contract for these services through AXIM Geospatial (formerly GIS, Inc.) as part of a GIS Support Block that was initiated in 2021. This agreement was for a specified number of hours of service and as of March, 2022 these hours have been exhausted.

As we move forward with the build and implementation of Command Point CAD it is essential that we continue to have access to GIS support as the program is heavily reliant on GIS data and personnel to make this data usable to all end users. Similarly, the processes to gather, edit, and load GIS data into CAD and the MDC maps are still being defined and need a large amount of support to do so. We anticipate this need continuing through the build process and after the specified "go live" date. At this moment, these services are a critical need to continue to forge ahead in the build process.

FINANCIAL ANALYSIS

Due to the critical ongoing need for GIS support the Center received a quote to initiate a new GIS Support Block with Axim Geospatial. The hourly rate for this support reduces depending on the total number of hours purchased. The total hourly rate for services in the Support Block when the total number of hours exceeds 374 is 147.06/hr. The Center's Board Approved FY 2021-22 budget includes \$60,000 for these services.
